Mr. P. M. Woods, President of the Ebarb Waterworks District, was present at the meeting and explained that he was in attendance to answer any questions that might arise relative to Item No. 9 on the agenda, "Consider an Ordinance Amending the District Boundaries of the Ebarb Waterworks District".

9. Consider an Ordinance Amending the District Boundaries of the Ebarb Waterworks District

Mr. McCormic questioned if the amended boundaries of the Ebarb Waterworks District would conflict with the boundaries of any other water districts. Mr. Woods explained that currently there are areas where the established boundaries of the water districts overlap and conflict. He stated that the new amended boundaries would resolve these overlaps of service and the new boundaries would no longer conflict with the boundaries of any other water district. Mr. Woods was asked if this action would cause a conflict with any other water district and he assured the Jury that it would not. He stated that, in fact, the implementation of the proposed ordinance would help to clear up any ambiguities.

ORDINANCE 3 of 2017

AN ORDINANCE AMENDING THE DISTRICT BOUNDARY OF THE EBARB WATERWORKS DISTRICT

WHEREAS, there are significant areas within Sabine Parish where a reliable source of potable water is not available to the citizens; and

WHEREAS, there is currently an overlap of franchise areas between the Ebarb Waterworks District and other water districts, and

WHEREAS, the Ebarb Waterworks District would benefit from an enlarged franchise area which would allow economies of scale and improved operating efficiencies,

NOW THEREFORE BE IT ORDAINED by the Sabine Parish Police Jury that the Resolution Creating the Ebarb Waterworks District, dated March 16, 1977; the Resolution Modifying the Boundaries of the Ebarb Waterworks District, dated October 19, 1977; and the Ordinance Ratifying, Approving, and Confirming Creation of Ebarb Waterworks District of Sabine Parish, Louisiana within Redesignated Boundaries, dated July 19, 1978 be hereby amended and that the entire boundary of the Ebarb Waterworks District shall be the following described property and territory situated in the Parish of Sabine, State of Louisiana, to-wit:

10. Consider an Ordinance Temporarily Moving the Polling Place for Precincts 6-4, 6-4a, 6-4b, and 8-2 From the North Sabine Fire Protection District Fire Station, 919 Hammond Street, Zwolle, Louisiana, to the Veterans of Foreign Wars Hall, 860 Dahlia Vines Road, Zwolle, Louisiana

The Sabine Parish Clerk of Court has informed the Sabine Parish Police Jury that the polling location for precincts 6-4, 6-4a, 6-4b, and 8-2 needs to be moved from the North Sabine Fire Protection District Fire Station located at 919 Hammond Street, Zwolle, Louisiana to the Veterans of Foreign Wars Hall located at 860 Dahlia Vines Road, Zwolle, Louisiana. Election day, October the 14th, is also the date of the Zwolle Tamale Fiesta. The current location of the poll is on the parade route and it will be very difficult for voters to access the poll.

AN ORDINANCE TEMPORARILY MOVING THE POLLING PLACE FOR PRECINCTS 6-4, 6-4a, 6-4b, AND 8-2 FROM THE NORTH SABINE FIRE PROTECTION DISTRICT FIRE STATION, 919 HAMMOND STREET, ZWOLLE, LOUISIANA TO THE VETERANS OF FOREIGN WARS HALL, 860 DAHLIA VINES ROAD, ZWOLLE, LOUISIANA

WHEREAS, the parish wide election scheduled for October 14, 2017 will fall on the weekend of the Zwolle Tamale Fiesta, and

WHEREAS, the polling place for Precincts 6-4, 6-4a, 6-4b, and 8-2 is located at 919 Hammond Street, Zwolle, Louisiana which is along the main parade route, and

WHEREAS, Hammond Street will be blocked and voters will be unable to access the polls

NOW THEREFORE BE IT ORDAINED, that, the polling place for precincts 6-4, 6-4a, 6-4b, and 8-2 be temporarily moved (for the October 14, 2017 election only) from the North Sabine Fire Protection District Fire Station located at 919 Hammond Street, Zwolle, Louisiana, to the Veterans of Foreign Wars Hall located at 860 Dahlia Vines Road, Zwolle, Louisiana. Subsequent to the October 14, 2017 election, the polling place for Precincts 6-4, 6-4a, 6-4b, and 8-2 will revert back to the North Sabine Fire Protection District Fire Station located at 919 Hammond Street, Zwolle, Louisiana

BE IT FURTHER ORDAINED, that this ordinance shall be in effect July 6, 2017 and it shall be published one time in the Official Journal of the Parish of Sabine, State of Louisiana, along with any other minutes of the meeting.
