#### 1. Call to Order

President Kenneth M. Ebarb called the meeting to order.

#### 2. Roll Call

The roll was called by the Secretary Treasurer. The following members were present: Willes Funderburk, "Mike" McCormic, Frances Hopkins, William E. Ruffin, "Ronny" Bison', Eric Garcie, Ricky "K-Wall" Sepulvado, Kenneth Ebarb, and "Randy" Byrd.

#### 3. Prayer

Prayer was led by Mrs. Frances Hopkins.

#### 4. <u>Pledge of Allegiance</u>

The Pledge of Allegiance was led by Mr. Willes Funderburk.

#### 5. Amend the Agenda

Resolution No. 7816

Motion by Ruffin and seconded by Garcie to amend the agenda as follows:

Item 7a – Mr. Walter Mains- Sabine Parish Waterworks District No. 1

Prior to a vote on the motion to take up a matter not on the agenda by this public body the Police Jury President allowed an opportunity for public comment on the motion. There being no public comments the vote was as follows:

Police Jury President, Kenneth M. Ebarb, allowed a period of public comment on any items on the agenda. Mr. Ebarb advised everyone that they would be allowed to comment later during the meeting on particular agenda items if they desire. There were no public comments at this time.

#### 7. Adopt the Minutes from Previous Meeting, February 15, 2017

All Police Jurors had previously been provided a written copy of the minutes of the regular meeting held February 15, 2017.

Motion by Sepulvado and seconded by Bison to adopt the minutes of the February 15, 2017 Police Jury meeting.

#### 7a. Mr. Walter Mains- Sabine Parish Waterworks District No. 1

Mr. Walter Mains, president of Sabine Parish Waterworks District No. 1, discussed different methods to accomplish a tie-in with the Robeline-Marthaville Water System as requested by several agencies including the D.H.H., the Governor's Office, and Delta Regional. The Robeline-Marthaville Water System has a need for more water and improved management.

Mr. Mains requested the Police Jury to authorize, by resolution, the Sabine Parish Waterworks District No. 1's application to the Community Water Enrichment Fund for emergency grant funds to provide an additional water supply to the Robeline-Marthaville Water System and to possibly manage that system. The maximum amount of emergency grant funds available is \$250,000.

Resolution No. 7819

Motion by McCormic and seconded by Ruffin:

WHEREAS, the Sabine Parish Waterworks District No.1 has an abundant water supply and significant experience in the management of a rural water system, and

WHEREAS, the Robeline-Marthaville Water System has a need for more water and improved management.

NOW THEREFORE BE IT RESOLVED, that the Sabine Parish Waterworks District No. 1 is authorized to apply to the Community Water Enrichment Fund for an emergency grant to provide an additional water supply to the Robeline-Marthaville Water System.

# 8. Mr. Lee Underwood - Balar Engineers and Surveyors

Mr. Lee Underwood with Balar Engineers and Surveyors addressed the Police Jury concerning the 2016 Louisiana Community Development Block Grant (LCDBG) Public

Facilities Program. On February 3, 2017, the Police Jury received notification that it had been awarded \$331,970 in grant funding to be used to rehabilitate six residential streets in the parish west of Zwolle and four streets in the parish west of Florien. On March 7, 2017, the Police Jury received authorization to incur costs related to the grant for planning and administration.

Mr. Underwood discussed the target areas of the grant which are for low to moderate income areas.

Mr. Underwood then reviewed changes in the grant application process for the upcoming 2018-2019 LCDBG grant period.

Mr. McCormic then directed several questions to Mr. Underwood concerning how the targeted roads were selected. Mr. Underwood explained that a list of roads was provided by the parish road superintendent and the secretary treasurer. Balar Engineers then examined the proposed roads and selected the roads best meeting the grant requirements for inclusion in the grant application. The Police Jury then reviewed and accepted the grant application.

# 9. Mr. Lewis McBryde – Sabine Humane Shelter

Mr. Lewis McBryde was not in attendance.

#### 10. Brian See- Roadside Inc.- Asphalt Zipper

Mr. Brian See with Roadside Inc. first addressed the Police Jury concerning the Parish's weed and brush abatement program. Roadside Inc. provides the spraying services for that program. Mr. See discussed the late spraying of the Parish's roads during 2016 and promised to spray the roads earlier, during the months of April or May, in 2017. Mr. See recommended spraying brush during the fall of the year.

The Asphalt Zipper is a portable reclamation and asphalt milling machine. The machine grinds existing asphalt road surface and converts it into road base material. The Asphalt Zipper can be attached to a grader or a front-end loader. Roadside, Inc. offered the Police Jury a free demonstration of the machine.

#### 11. Consider Hiring Human Resources Consultant

The Sabine Parish Police Jury has received a proposal, dated March 6, 2017, for a compensation plan study from SSA Consultants located in Baton Rouge, Louisiana. Each Juror was provided a copy of the proposal.

The Sabine Parish Police Jury is facing rising compensation and benefit costs but desires to be competitive and offer fair compensation to current and future employees. The Police Jury is considering hiring a human resources consultant to assist in ensuring that the Parish's job descriptions accurately set forth the duties of each employment position and that the compensation plan motivates and rewards employees. SSA Consultants has a long history of conducting compensation and classification studies in both the public and private sectors, including a recent study for DeSoto Parish.

President Ebarb briefly discussed some of the issues and problems that have been encountered while dealing with the existing job classifications and employment policies of the Jury, including employee leave and leave accrual. President Ebarb stressed that the Police Jury values its employees and will not do anything to their detriment.

The Personnel Committee and the Finance Committee had previously reviewed the proposal and both committees recommended engaging SSA Consultants to perform a compensation and classification study.

Mr. Sepulvado questioned if there would be any cost savings to the citizens of the Parish as a result of this study. Mr. Bison assured him that there would be sufficient savings in the first year to justify the study. Mr. McCormic noted that the employee leave program is not meant to be a supplemental retirement plan for the employees. Mr. Ruffin discussed the possibility of limiting the amount of leave that an employee can accumulate.

Resolution No. 7820

Motion by McCormic and seconded by Sepulvado to engage SSA Consultants to perform a compensation and classification study for the Police Jury at a fee not to exceed \$19,500 and to authorize President Kenneth Ebarb to execute any documents necessary to enter into the contractual agreement.

14. Wesley Johnson- E&P Consulting Services, LLC – Adjudicated Property Wesley Johnson, with E&P Consulting Services, LLC, addressed the Police Jury concerning adjudicated property. Ms. Johnson's office is in Monroe, Louisiana. Some of the services offered by E&P Consulting Services, LLC include:

- Draft the original ordinance for the Police Jury's use in complying with the adjudicated property laws.
- Meet with relevant individuals to ensure a smooth start to the program.
- Accept applications from interested purchasers of Parish adjudicated property.
- Communicate offer document to interested property purchaser.
- Perform title search.
- Send all statutorily required notifications via certified mail.
- Provide script for news publication to relevant newspaper.
- Schedule auction.
- Handle closing and collect purchase price.

E&P Consulting Services, LLC will handle the disposition of any parcel of adjudicated property, regardless of size. However, the Company does not actively market properties and only becomes involved in the sale when notified that there is an interested purchaser.

The Sabine Parish Police Jury is currently under contract with CivicSource to sale its adjudicated property, but CivicSource has indicated that some properties will have too small of a value to be sold through their program.

Motion by McCormic and seconded by Bison to use E&P Consulting Services, LLC to dispose of adjudicated properties not accepted for sale by CivicSource.

Mrs. Denise Rogers then addressed the Police Jury concerning Shamrock Road. Dirt work done by a landowner has encroached the right of way for the road and inhibited drainage of rain water. In addition, gravel has been piled on the road right of way and, in some areas, the width of the road has been reduced to a single lane.

Mr. Bison stated that the landowner needs to meet with the Parish Road Superintendent, Doug Olivier, to address these issues. President Ebarb instructed the Parish Road Superintendent to meet with the Parish Planning Commission Chairman, Peter Nugent, to determine the actions to be taken to alleviate these problems.

The resolution is the first step in the FY 2018/2019 LCDBG application process.

# A RESOLUTION ADOPTING A CITIZEN PARTICIPATION PLAN FOR THE CDBG PROGRAM

WHEREAS, Sabine Parish Police Jury desires to obtain Community Development Block Grant (CDBG) funds to benefit Low and Moderate Income persons; and

WHEREAS, the Louisiana Division of Administration requires that certain citizen participation requirements be met;

NOW, THEREFORE, BE IT RESOLVED that the following Citizen Participation Plan is adopted for use by the Sabine Parish Police Jury with respect to planning, implementation, and assessment of its CDBG program:

This plan describes how the Sabine Parish Police Jury intends to involve citizens in the planning, implementation, and assessment of the local Community Development Block Grant Program. Federal and State regulations give ultimate responsibility for the design and implementation of the program to local elected officials and also require that citizens be given an opportunity to serve in a key advisory role to the elected officials. All aspects of citizen participation will be conducted in an open manner with freedom of access to information for all interested persons.

# CITIZEN PARTICIPATION PLAN

The Sabine Parish Police Jury has adopted the following Citizen Participation Plan to meet the citizen participation requirements of Section 508 of the Housing and Community Development Act of 1974, as amended. The Sabine Parish Police Jury is

committed through adoption of this plan to full and total involvement of all residents of the community in the composition, implementation and assessment of its Louisiana Community Development Block Grant (LCDBG) Program. Attempts will be made to reach all citizens, with particular emphasis on participation by persons of low and moderate income, residents of slum and blighted areas and of areas in which funds are proposed to be used. A copy of this plan will be made available to the public upon request.

As part of the citizen participation requirements and to maximize citizen interaction, the Sabine Parish Police Jury shall:

- 1) Provide citizens with reasonable and timely access to local meetings, information and records relating to the state's proposed method of distribution, as required by the Secretary, and relating to the actual use of funds under Title I of the Housing and Community Development Act of 1974, as amended;
- 2) Provide for public hearings to obtain views and respond to proposals and questions at all stages of the community development program. These hearings will consist of the development of needs and proposed activities and review of program performance. These hearings will be held after adequate notice, a minimum of five calendar days, at times and locations convenient to potential or actual beneficiaries with accommodations for persons with disabilities;
- 3) Provide for and encourage citizen participation with particular emphasis on participation by persons of low and moderate income who are residents of slum and blighted areas and of areas in which funds are proposed to be used;
- 4) Provide for technical assistance to groups representative of persons of low and moderate income that request such assistance in developing proposals;
- 5) Where applicable, identify how the needs of non-English speaking residents will be met in the case of public hearings; and
- 6) Provide for a formal written procedure which will accommodate a timely written response, within fifteen days where practicable, to written complaints and grievances.

Written minutes of the hearings and an attendance roster will be maintained by the Sabine Parish Police Jury.

# **PUBLIC HEARINGS**

Notices informing citizens of any public hearings will appear in the official journal of the Sabine Parish Police Jury a minimum of five calendar days prior to the hearing. In addition, notices will also be posted at the police jury office and the hearing will be publicized through local community organizations, i.e., churches, clubs, etc., and/or dissemination of leaflets in the target area. Hearings will be held at times and locations convenient to potential or actual beneficiaries with accommodations for individuals with disabilities and non-English speaking persons. Whenever possible these hearings will be held within or near the target areas, at times affording participation by the most affected residents.

#### I. APPLICATION

#### First Notice/Public Hearing

The public hearing to address LCDBG application submittal will be held well in advance of the deadline for submission of the application for the current funding cycle. The Citizen Participation Plan will be available at the hearing. The public notice for this hearing will state that the following will be discussed:

- a) The amount of funds available for proposed community development;
- b) The range of activities that may be undertaken, including the estimated amount proposed to be used for activities that will benefit persons of low and moderate income;
- c) The plans of the Sabine Parish Police Jury for minimizing displacement of persons as a result of activities assisted with such funds and the benefits to be provided by the Sabine Parish Police Jury to persons actually displaced as a result of such activities; and
- d) The Sabine Parish Police Jury's prior performance of LCDBG programs funded by the State of Louisiana. In addition, the notice shall state that all citizens, particularly low and moderate income residents of slum and blighted areas, are encouraged to submit their views and proposals regarding community development and housing needs. Those citizens unable to attend this hearing may submit their views and proposals to:

The notice will also state that accommodations will be made for disabled and non-English speaking individuals provided a 3 day notice is received by the Sabine Parish Police Jury.

#### Second Notice

Seven calendar days, at a minimum, prior to the deadline for submittal of the application, a second notice shall appear in the official journal informing the citizens of the following:

- a) Proposed submittal date of the application;
- b) Proposed objectives;
- c) Proposed activities;
- d) Location of proposed activities;
- e) Dollar amount of proposed activities; and
- f) Location and hours available for application review.

In addition, the notice shall state "all citizens, particularly those affected by the proposed project, are encouraged to review the proposed application and submit any written comments on the application to:

Negative comments received will be forwarded to the state's Office of Community Development, Division of Administration or the application will be withdrawn if necessary.

# II. AMENDMENTS

Program amendments, which substantially alter the LCDBG project from that approved in the original application, shall not be submitted to the state without holding one public hearing in accordance with the procedures outlined within this Citizen Participation Plan. Minutes of the hearing will be submitted with the request for the amendment. All interested citizens, particularly the low and moderate income, elderly, handicapped, and residents of the project area, shall be made aware and have the opportunity to comment on proposed amendments and/or submit alternative measures.

#### III. GRANTEE PERFORMANCE

The Sabine Parish Police Jury will hold one performance hearing to solicit the public's opinion of the effectiveness of the LCDBG Program. The manner of notification will be the same as previously described for all public hearings. Notification will be made in the official journal approximately five to fifteen calendar days prior to the anticipated submittal of close-out documents to the state, and will indicate the date, time, and place of the performance hearing, and invite comments and opinions on the LCDBG activities implemented under the Sabine Parish Police Jury LCDBG Program being closed out. The notice will also state that accommodations will be made for disabled and non-English speaking persons provided a three day notice is received by the Sabine Parish Police Jury.

This notice shall invite all interested parties, particularly those low to moderate income residents in the target area to attend.

The hearing will be held no sooner than five calendar days from the publication date of said notice.

# CONSIDERATION OF OBJECTION TO APPLICATION

Persons wishing to object to approval of an application by the state may make such objection known to:

The state will consider objections made only on the following grounds:

- i. The application description of needs and objectives is plainly inconsistent with available facts and data;
- ii. The activities to be undertaken are plainly inappropriate to meeting the needs and objectives identified by the applicant; and
- iii. The application does not comply with the requirements set forth in the state's Annual Action Plan or other applicable laws.

Such objections should include both an identification of the requirements not met and, in the case of objections relative to (1) above, the complainant must supply the data upon which he/she relied upon to support his/her objection.

# **BILINGUAL**

Whenever a significant number of persons and/or residents of blighted neighborhoods communicate with a primary language other than English attend public hearings, the Sabine Parish Police Jury will provide an interpreter for dissemination of information to them providing the Sabine Parish Police Jury is given sufficient notification of three day(s).

# TECHNICAL ASSISTANCE

Technical assistance may be provided directly by the Sabine Parish Police Jury to any citizen, particularly to low and moderate income persons, residents of blighted neighborhoods and minorities, who request assistance in the development of proposals and statement of views concerning the LCDBG Program. The local officials, administrator and engineer will conduct informational meetings with the residents of the low to moderate income areas if a written request is received by the Sabine Parish Police Jury with at least a one week notification. The person who conducts the technical assistance meetings will disseminate information on the program and answer all pertinent questions.

#### TIMELY ACCESS AND ADEQUATE INFORMATION

The Sabine Parish Police Jury shall provide timely disclosure of records, information and documents related to the LCDBG program activities. Documents will be made available for copying upon request at Sabine Parish Police Jury, Monday thru Friday, 8:00a.m. to 3:00p.m. Such documents may include the following:

- 1) All meetings and promotional materials.
- 2) Records of hearings and meetings.
- 3) All key documents, including prior applications, letters, grant agreements, citizen participation plans, and proposed applications.
- 4) Copies of the regulations (final statements) concerning the program.
- 5) Documents regarding other important requirements, such as Procurement Procedures, Fair Housing, Equal Employment Opportunity, Uniform Act, Labor Provisions and Environmental Procedures.

#### CITIZEN COMPLAINT PROCEDURE

#### **SECTION 1**

It is the policy of Sabine Parish to review all complaints received by the Parish.

#### **SECTION 2**

The following procedures will be followed on all complaints received by the Sabine Parish Police Jury:

- 1) The complainant shall notify the Parish Secretary-Treasurer of the complaint. The initial complaint may be expressed orally or by written correspondence.
- 2) The Parish Secretary-Treasurer will notify the President or designated representative of the complaint within two working days.
- 3) The President or designated representative will investigate the complaint and will report the findings to the Parish Secretary-Treasurer within five working days.
- 4) The Parish Secretary-Treasurer will notify the complainant of the findings of the President or designated representative in writing or by telephone within two working days.
- 5) If the complainant is aggrieved by the decision, he must forward the complaint in writing (if previously submitted orally) to the Parish Secretary-Treasurer who will forward the complaint and all actions taken by the President or designated representative to the appropriate Sabine Parish Police Jury committee for their review. This will be accomplished within two working days of receipt of the written complaint.
- 6) The reviewing Police Jury committee will have five working days to review the complaint and forward their decision to the complainant in writing.
- 7) If the complainant is aggrieved with the decision of the Police Jury Committee, he must notify the Parish Secretary-Treasurer in writing that he/she desires to be afforded a hearing by the Police Jury. The complainant will be placed on the next regularly scheduled police jury meeting agenda. The Parish Secretary-Treasurer will notify the complainant in writing of the date of the hearing.
- 8) The complainant must bring all relevant data, witnesses, etc., to the hearing. The Sabine Parish Police Jury, at the hearing, will review the complaint and forward within five days a certified copy of the minutes of the meeting at which the hearing was conducted and a decision was rendered to the complainant. If a decision is not reached at the hearing, the Sabine Parish Police Jury will inform complainant of an appropriate date to expect a response. Within two working days of reaching a decision, the complainant will be notified in writing of the decision.

#### **SECTION 4**

The Secretary-Treasurer will maintain a file for the purpose of keeping reports of complaints.

#### **SECTION 5**

This policy does not invalidate nor supersede the personnel or other policies of the Sabine Parish Police Jury which are currently adopted, but is intended to serve as a guide for complaints.

This policy may be amended by a majority vote at any of the Sabine Parish Police Jury's regularly scheduled meetings.

# 18. <u>Consider Entering a Cooperative Endeavor Agreement with Sabine Parish Dixie Youth Baseball, Inc.</u>
