8. Planning Commission

No members of the Parish Planning Commission were present at the meeting.

9. Mr. Malcolm Franks, President of the South Toledo Bend Water District

Mr. Malcolm Franks, President of the South Toledo Bend Water District addressed the Police Jury. Mr. Franks explained that due to a study conducted by the Long-Range Planning Committee for Sabine Parish, it has come to the attention of the South Toledo Bend Water District that some of the customers to which it is providing service are located outside the District's franchise area. However, these customers are not included in any other water district's franchise area either. South Toledo Bend Water District also desires to extend service to additional customers desiring water in areas not currently offered service.

In order to address these issues, it is necessary for the boundaries of the South Toledo Bend Water District to be clarified. Mr. Franks requested that the Police Jury amend the boundaries of the District prior to them beginning this work. The District's engineers have prepared a map and a description of proposed boundaries. These proposed boundaries will not encroach upon any other water system.

Mr. McCormic noted that the areas the District is requesting to extend service into are sparsely populated. Mr. Franks agreed and explained that providing service in these areas was the purpose of the District.

10. Consider an Ordinance Amending the District Boundaries of the South Toledo Bend Water District

On May 8, 2017, the Board of Commissioners of the South Toledo Bend Water District adopted Resolution 5.8.2017 petitioning the Sabine Parish Police Jury to expand the District's boundaries to match the proposal from Meyers & Associates.

A copy of the proposed boundary description and a map of the proposed boundary for the South Toledo Bend Water District has been provided to each juror.

ORDINANCE 2 of 2017

AN ORDINANCE AMENDING THE DISTRICT BOUNDARY OF THE SOUTH TOLEDO BEND WATER DISTRICT

WHEREAS, there are significant areas within Sabine Parish where a reliable source of potable water is not available to the citizens; and

WHEREAS, there are significant areas within Sabine Parish where suitable fire protection is not available; and

WHEREAS, the South Toledo Bend Water District would benefit from an enlarged franchise area which would allow economies of scale and improved operating efficiencies,

NOW THEREFORE BE IT ORDAINED by the Sabine Parish Police Jury that the entire boundary of the South Toledo Bend Waterworks District shall be the following described property and territory situated in the Parish of Sabine, State of Louisiana, to-wit:

11. Amend the 2017 Budget for Ward No.1

Due to extensive repairs to roads damaged by the flooding of March 2016, the gravel and rock expenditures of Ward 1, Road District 18, have exceeded the amount budgeted for 2017. The majority of the funding for these repairs will be received from federal grants through FEMA (Federal Emergency Management Agency). It is proposed that the 2017 budget for Ward 1, Road District 18, be amended to recognize federal revenues from FEMA and to increase expenditures for gravel and rock.
