1. Call to Order

President Mike McCormic called the meeting to order.

9. <u>Authorize the President of the Police Jury to Enter a Capital Lease Agreement with Sabine State Bank for the Purchase of a Trash Compactor</u>

The Sabine Parish Police Jury has received a draft of a capital lease agreement with Sabine State Bank & Trust Company to finance the purchase of a Caterpillar Model 826K landfill compactor at a cost of \$647,432.99. Each Juror was presented a copy of the agreement.

Resolution No. 8533

Motion by Byrd and seconded by Sepulvado:

WHEREAS the Sabine Parish Police Jury has publicly bid for the purchase of a landfill compactor and the winning bid was from Louisiana Machinery Company, LLC for a Caterpillar Model 826K landfill compactor at a cost of \$647,432.99, and

WHEREAS the Police Jury desires to purchase this landfill compactor through a capital lease agreement, and

WHEREAS, Sabine State Bank & Trust Company has offered to provide funding for this purchase through a lease agreement that includes a non-appropriation clause and does not include a non-substitution clause,

NOW THEREFORE BE IT RESOLVED, that the Sabine Parish Police Jury President is hereby authorized to sign all documents necessary to execute a capital lease for a Caterpillar Model 826K landfill compactor at a cost of \$647,432.99.

10. Approve Entering Landfill Waste Sales Agreement

The Sabine Parish Police Jury renewed its operation of the solid waste landfill on March 1, 2020.

The Solid Waste Committee has determined that a salesman whose duties would include generation of new business and maintenance of existing business is needed for profitable operation of the landfill.

The Solid Waste Committee has met with Bridlington Company, LLC and negotiated for the provision of these services. After a meeting with a principal of the company, the agreement was modified to satisfy the requirements of the Solid Waste Committee. A copy of the amended agreement has been provided to each juror.

WHEREAS, the Police Jury is in need of a salesman to generate new business and to maintain existing customer accounts, and

WHEREAS, Bridlington Co., LLC has agreed to provide these services to the Police Jury,

NOW THEREFORE BE IT RESOLVED, that the Sabine Parish Police Jury President is hereby authorized to sign all documents necessary to execute an agreement with Bridlington Co., LLC to provide sales and account maintenance services for the Sabine Parish Sanitary Landfill.

11. Consider an Ordinance Controlling the Flow of Solid Waste Within Sabine Parish

ORDINANCE 1 of 2020

AN ORDINANCE TO PROVIDE FOR A SOLID WASTE PROGRAM, RULES AND REGULATIONS PERTAINING TO SAME, AND PENALTIES FOR VIOLATIONS THEREOF

WHEREAS, the Sabine Parish Police Jury shall establish and operate a Solid Waste Landfill,

NOW THEREFORE BE IT ORDAINED, that:

- 1. The Sabine Parish Police Jury shall establish a parish-wide solid waste facility to satisfy the requirements of Louisiana and Federal laws. The operation and use of the Sabine Parish Sanitary Landfill shall be determined by the Sabine Parish Police Jury.
- 2. The Sabine Parish Sanitary Landfill shall be established and operated under permit authority of the State of Louisiana Department of Environmental Quality (DEQ).

BE IT FURTHER ORDAINED, that:

- 1. All solid waste except as otherwise defined, shall be deposited in designated containers for storage and subsequent transportation to the landfill.
- 2. All material of a spoilable nature shall be deposited in the compactor stations provided for this purpose.
- 3. All construction material, brush, tree limbs, fencing, major household appliances and furniture, and other non-degradable material shall be deposited in containers provided for this purpose.
- 4. All containers shall be plainly marked for type of material and instructions shall be conspicuously placed at each station.
- 5. All entry to the landfill shall be controlled by the superintendent and his staff.
- 6. Any person entering a Parish-owned waste disposal facility shall hold the Parish and its contractors harmless from any liabilities which cause injury or damage to persons or property, subject, however, to acts of negligence by the Parish or its contractors in the operation of the waste disposal facility.
- 7. Any person entering a Parish-owned waste disposal facility shall be required to abide by all posted rules and regulations established by the Police Jury.
- 8. Any person entering a Parish-owned solid waste disposal facility from any area other than the designated entrance will be considered to be a trespasser and will be subject to prosecution pursuant to applicable law.
- 9. No person under the age of 13 shall be allowed out of the vehicle while in the active dumping area.
- 10. No person shall be allowed to smoke while in the active dumping area.
- 11. The speed limit on the waste disposal site shall be 25 miles per hour.
- 12. No person shall scavenge or salvage for any material which has been deposited at the landfill, at any container site, or in any container or compactor.
- 13. Refuse from any commercial operator shall be accepted only if prior agreement has been made.
- 14. No person shall be allowed to abuse the equipment of the parish collection and disposal system.
- 15. No person shall be allowed to promiscuously dump trash or refuse within the boundaries of Sabine Parish.
- 16. No person or corporation shall organize and initiate a collection and disposal system for solid waste within Sabine Parish without the express written approval of the Sabine Parish Police Jury.
- 17. No commercial collector or generator of commercial wastes may use the compactor facilities of the parish solid waste system.
- 18. All waste entering the waste disposal facility is subject, prior to acceptance at the site, to inspection to determine compliance with the state waste permit.
- 19. All solid waste, special waste, trash and refuse generated within the limits of the parish by commercial businesses and collectors of waste, whether commercial or privately generated, shall be disposed of at the Sabine Parish Sanitary Landfill at the established tipping fee rate.

BE IT FURTHER ORDAINED, that:

- 1. The following penalties for conviction resulting from a violation of this ordinance or any provisions of this ordinance are hereby established:
 - a. First Conviction Whoever violates the provisions of this ordinance shall, upon first conviction, be fined not less than One Hundred Dollars nor more than Three Hundred Dollars, and/or imprisoned for up to thirty days.
 - b. Second Conviction Whoever violates the provisions of this ordinance shall, upon second conviction, be fined not less than Three Hundred Dollars nor more than Five Hundred Dollars, and/or imprisoned for up to thirty days.

BE IT FURTHER ORDAINED, that this ordinance shall be in effect May 1, 2020 and it shall be published one time in the Official Journal of the Parish of Sabine, State of Louisiana, along with any other minutes of the meeting.

BE IT FURTHER ORDAINED, that all ordinances, or parts of ordinances in conflict herein be and the same are hereby repealed, after this ordinance goes into effect.

The foregoing ordinance having been offered upon a motion by Brown and seconded by Stewart was then submitted to an official vote and the vote thereupon was recorded as follows to wit:

Funds were budgeted in the 2020 Annual Financial Budget to purchase this vehicle.

15. <u>Authorize Advertising for Bids for a Water Truck for the Solid Waste Landfill</u> The Louisiana Department of Environmental Quality requires the roads in the solid waste landfill to be kept damp to prevent airborne dust particles. The Police Jury is investigating the possibility of purchasing a used water truck for use at the solid waste landfill. It is anticipated that a good used water truck can be purchased for less than \$30,000.

Resolution No. 8538

Motion by Ruffin and seconded by Brown:

WHEREAS, a water truck is needed at the solid waste landfill to keep the roads damp to prevent airborne dust particles.

NOW THEREFORE BE IT RESOLVED that the Solid Waste Committee is hereby authorized to obtain at least three quotes for a used water truck, and

BE IT FURTHER RESOLVED that the Solid Waste Committee is authorized to review the quotes and purchase the water truck of their choice provided the cost of the vehicle is less than \$30,000.

16. <u>Authorize Hiring Temporary Employees for Pot-Hole Crews</u>

Because of the COVID-19 virus, the Police Jury has been unable to utilize inmate crews to repair potholes in parish roads. President McCormic suggested hiring temporary employees to make these pothole repairs. Mr. Brown inquired if the Jury could hire high school students for these positions. Secretary Treasurer Weatherford informed the Jury that minors could be hired if the proper documentation is obtained from the Louisiana Department of Labor.

Road Superintendent Hughes requested six (6) temporary employees be hired.

Motion by Ebarb and seconded by Davidson to authorize hiring up to six (6) temporary employees to work primarily to repair potholes in parish roads at a rate of pay of ten dollars (\$10.00) per hour. They will be hired subject to passing the normal physical and drug test and will work until inmate crews are again available to the Parish.
