A RESOLUTION APPROVING AN ANNUAL PAYMENT IN LIEU OF TAX IN ACCORDANCE WITH A TERM SHEET ISSUED BY THE NORTHWEST LOUISIANA FINANCE AUTHORITY TO HOLLIS CREEK PV I, LLC.

WHEREAS, the Northwest Louisiana Finance Authority ("NLFA") is a statutorily authorized local public trust permitted to acquire and hold property for one or more of its public purposes as set forth in R.S. 9:2341(B) and upon acquisition by NLFA, such property is declared for purposes of R.S. 9:2347(M) to be public property used for essential and governmental purposes and such property is thereby exempt from all taxes of the Parish, the state of Louisiana (the "State"), or any political subdivision thereof or any other taxing body; and

WHEREAS, NLFA has arranged to acquire a solar photovoltaic facility (the "Solar Project") and potentially an optional Energy Storage facility (the "Optional Energy Storage Project," and together with the Solar Project, the "Project") in the Parish of Sabine (the "Parish")

pursuant to a Term Sheet issued to Hollis Creek PV I, LLC (the "*Term Sheet*"), which is attached hereto as **Exhibit A** and incorporated herein; and

WHEREAS, NLFA intends to lease the Project to Hollis Creek PV I, LLC (the "Lessee"), a limited liability company organized and existing under the laws of the state of Delaware and qualified to do business in the State, and pursuant to La. R.S. 9:2347(M) and subject to the approval of the Sabine Parish Police Jury, as the governing authority of the Parish, and the approval of the beneficiary of NLFA, NLFA will require the Lessee to pay annually to parish or municipal taxing authorities, and to any other taxing body in the Parish, through the entity responsible for collecting ad valorem taxes for each taxing body (collectively, the "Tax Collector"), a sum in lieu of ad valorem taxes in an amount not to exceed the amount of taxes that would otherwise be due if the Project were not owned by the Authority (a "PILOT"), in accordance with the Term Sheet, in order to compensate such authorities for services rendered by them to the Project, which sum the Tax Collector shall collect and enforce payment of in accordance with the statutory provisions of La. R.S. 39:1002 as statutory impositions; and

**WHEREAS**, the Term Sheet provides that the PILOT shall commence upon the conveyance of the Project to the Authority and shall terminate at 11:59 P.M. on the last day of the two hundred and fortieth (240) month after commencement (the "PILOT Termination Date"), and that full ad valorem taxes will be paid to the Tax Collector following the PILOT Termination Date; and

**WHEREAS**, as an independently existing public trust authorized and empowered under Chapter 2-A of Title 9 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 9:2341 through 9:2347, inclusive) (the "Act"), the PILOT for the Project may be required by NLFA only if the Sabine Parish Police Jury, as the governing authority within whose boundaries the Project is to be located, approves by resolution the PILOT, in accordance with La. R.S. 9:2347(M);

**NOW, THEREFORE, BE IT RESOLVED** by the Police Jury of the Parish of Sabine that:

- <u>Section 1.</u> The foregoing whereas clauses are hereby adopted as set forth in the preamble to this Resolution.
- <u>Section 2.</u> This Parish does hereby approve the PILOT to be paid by the Lessee for the Project in an amount not to exceed the amount of taxes that would otherwise be due if the Project were not owned by the Authority, in accordance with the Term Sheet.
- <u>Section 3</u>. The President and Secretary-Treasurer are hereby authorized, empowered, and directed to take forthwith any and all such action as may be necessary to carry into effect the provisions of this Resolution.
- <u>Section 4</u>. If any one or more of the provisions of this Resolution shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Resolution, but this Resolution shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after

the date of this Resolution which validates or makes legal any provision of this Resolution which would not otherwise be valid or legal, shall be deemed to apply to this Resolution.

<u>Section 5</u>. This Resolution shall immediately take effect upon adoption.

16. Adopt a Resolution Authorizing the Engagement of Counsel for the Purpose of Negotiating the Purchase of Sabine Parish Property, and/or Expropriating Such Property, for Public Use, Namely to Expand the Existing Sabine Parish Landfill

#### Resolution No. 9251

The following Motion and Resolution was offered by Ruffin who moved for its adoption, and seconded by Steinke at the April 19, 2023 meeting of the Sabine Parish Police Jury (the "Police Jury"):

WHEREAS, the Police Jury requires counsel for the purposes of negotiating the purchase of Sabine Parish property, and/or expropriating such property, for public use, namely to expand the existing Sabine Parish landfill; and

WHEREAS, the Police Jury does not have counsel on its staff, and the Sabine Parish District Attorney's Office has advised that it does not have civil experience with expropriation actions, nor sufficient resources to promptly assist with these matters; and

WHEREAS, The Police Jury proposes to retain the following outside counsel for these purposes, at the following legal rates:

- 1. J. Chris Guillet, Corkern, Crews, Guillet & Johnson, LLC, 616 Front Street, Natchitoches, Louisiana (318-352-2302), \$250 per hour.
- 2. Mark Begnaud, McCoy, Roberts & Begnaud, 300 St. Denis Street, Natchitoches, Louisiana (318-352-6495), \$250 per hour.

These attorneys have experience in commercial matters, property valuation, the representation of parish governing authorities, and expropriation. The Police Jury does not anticipate paying for duplicate services; rather, both of these lawyers are practitioners in small firms that shall associate with one another for the purposes of properly dividing the tasks in the case, to move the matters promptly (similar to the manner in which associates operate in large law firms); and

WHEREAS, the hourly rate shall be \$250.00, because both of these counsel have more than twenty years of experience in the practice of law, with extensive commercial and real estate experience, as well as extensive trial experience, and experience representing public bodies; this rate is equal to or less than typical legal rates in this area for comparable legal work; and

WHEREAS the term shall be October 4, 2022 through the completion of the purchase or expropriation of the property necessary to expand the landfill facilities in Sabine Parish; and

WHEREAS, the scope of this legal representation does not involve federal claims; and

WHEREAS, this resolution shall take effect immediately; and

THEREFORE BE IT RESOLVED, that the Sabine Parish Police Jury, pursuant to La. R.S. 42:262 and applicable law, does hereby retain and employ the law firms of J. Chris Guillet, Corkern, Crews, Guillet & Johnson, LLC and Mark Begnaud, McCoy, Roberts & Begnaud as special counsel; and

BE IT FURTHER RESOLVED, that this Resolution and proposed contract described herein be submitted to the Attorney General for the State of Louisiana for approval.

19. Authorize a New Position for an Additional Operator at the Solid Waste Landfill The Solid Waste Committee met March 31, 2023. Mr. Pete Chreene, Superintendent of the Sanitary Landfill, reported that mud sales have increased significantly at the landfill. He is currently renting an excavator and an articulated haul truck to handle the increase in the volume of sales. He requested that a position for an additional equipment operator be established to provide an employee to operate the added equipment. The Solid Waste Committee has recommended creating an additional equipment operator position at the landfill.

The following resolution was offered by Ebarb and seconded by Byrd:

#### RESOLUTION

A resolution approving the issuance, sale and delivery of not exceeding Three Hundred Five Thousand Dollars (\$305,000) of Limited Tax Bonds, Series 2023, of Wards 1 and 2 Fire Protection District No. 1 of the Parish of Sabine, State of Louisiana.

WHEREAS, Wards 1 and 2 Fire Protection District No. 1 of the Parish of Sabine, State of Louisiana (the "District"), proposes to issue not exceeding \$305,000 of Limited Tax Bonds, Series 2023 (the "Bonds") for the purpose of constructing and improving fire protection facilities for the Issuer, including purchasing fire fighting equipment and emergency equipment for the Issuer and paying costs of issuance of the Bonds; and
