ORDINANCE NO. 5 OF 2023

AN ORDINANCE TO ESTABLISH AND MERGE PRECINCTS CONSISTENT WITH THE 2022 SABINE PARISH POLICE JURY DISTRICTS IN ACCORDANCE WITH LOUISIANA REVISED STATUTES 18:532 AND 18:532.1

WHEREAS, the Sabine Parish Police Jury is required by law to reapportion its districts pursuant to the findings of the 2020 Federal U.S. census;

WHEREAS, the districts shall be reapportioned to meet applicable state and federal guidelines;
WHEREAS, the 2022 Sabine Parish Police Jury Redistricting Ordinance adopted on November 16,2022 created split precincts throughout the parish;

WHEREAS, all governing bodies with districts in Sabine Parish has completed redistricting based on the 2020 US Census;

WHEREAS, the Sabine Parish Police Jury is merging and consolidating precincts to facilitate voting and to reduce the number of precincts and polling places throughout the parish; and

THEREFORE, BE IT ORDAINED by the Sabine Parish Police Jury, Many, Louisiana:

## SECTION 1:

There are hereby established thirty (30) Precincts for the Parish of Sabine, the boundaries, territories, and designations of which are as follows:
