11. <u>Appoint Dr. Sarah Ebarb as the New Sabine Parish Representative to the Northwest</u> Louisiana Human Services District

James Tidwell resigned as Sabine Parish's representative on the board of the Northwest Louisiana Human Services District on September 10, 2023. The District has requested the Police Jury to identify and appoint a new Sabine Parish representative to the District Board.

Act 73 of the 2017 Louisiana regular session sets the required composition of the Board to include members with professional or personal knowledge in mental health, additive disorders, developmental disabilities, finance, the judiciary, specialty courts, law enforcement, school-based healthcare, public health, or the coroner's office. The representative must also live and/or work in Sabine Parish.

Dr. Sarah Ebarb briefly discussed her qualifications to serve as a representative to the Northwest Louisiana Services District.

12. <u>Alex Washington – Consider Entering an Agreement to Seek Damages for Water</u> Contamination

Mr. Alex Washington addressed the Jury concerning possible damages by 3M for water contamination. He requested permission to test water in Sabine Parish for contamination. He asked the Police Jury to enter into a legal services agreement to litigate a settlement if contamination is discovered. There will be no costs incurred by the Police Jury if there is no recovery of damages.

A Resolution Authorizing the Execution of a Legal Services Agreement with Baron & Budd, P.C., Cossich, Sumich, Parsiola & Taylor, L.L.C., Washington and Wells Law Firm, and Ronald J. Miciotto, L.L.C, and to Otherwise Provide with Respect Thereto

Motion by Ruffin and seconded by Stewart:

WHEREAS. The Police Jury of Sabine Parish ("Police Jury") desires to engage outside counsel Baron & Budd, P.C., Cossich, Sumich, Parsiola & Taylor, L.L.C., Washington and Wells Law Firm, and Ronald J. Miciotto, L.L.C ("Outside Counsel") to represent the Police Jury, including but not limited to its boards, commissions, and agencies in this matter and seeks to enter into a Legal Services Agreement with the Outside Counsel in relation thereto; and

WHEREAS, the Police Jury, including its boards, commissions, or agencies, has the right and/or obligation to pursue claims for damages, compensation and other relief (the "Cause of Action") against the manufacturer(s) and supplier(s) of firefighting foam products (known as "aqueous film forming foam" or "AFFF") and/or other products containing per- and polyfluoroalkyl substances ("PFAS") (including perfluorooctanoic acid (:PFOA") perfluorooctane sulfonate ("PFOS") and any other related compounds); and

WHEREAS, Police Jury, acting as the governing authority of the Sabine Parish, desires that the Outside Counsel be retained as special counsel for this purpose; and

WHEREAS, the "Outside Counsel" have proposed to represent the Police Jury with no fee charged unless a recovery is obtained.

NOW, THEREFORE, BE IT RESOLVED Police Jury of Sabine Parish in due, regular and legal session convened that the President of the Police Jury be and he is hereby authorized to execute, for and on behalf of the Police Jury of Sabine Parish, a Legal Services Agreement with Baron & Budd, P.C., Cossich, Sumich, Parsiola & Taylor, L.L.C., Washington and Wells Law Firm, and Ronald J. Miciotto, L.L.C to provide legal representation, counsel, and advice to the Police Jury of Sabine Parish,

BE IT FURTHER RESOLVED, That if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or applications, and to this end, the provisions of this resolution are hereby declared to be severable. BE IT FURTHER RESOLVED, that all resolutions or parts thereof in conflict herewith are hereby repealed.

13. Kendra Brevelle – Mission Boost LLC – Grant Writer

Kendra Brevelle with Mission Boost, LLC addressed the Police Jury. Mission Boost LLC is a company located in Echo, Louisiana that is led by an experienced grant writer and consultant with over twenty years of experience in managing federal, state and local grants. Ms. Brevelle discussed her experience and qualifications.

14. Mike Busada – Adopt a Resolution Approving Payment in Lieu of Tax Agreements in Accordance with a Term Sheet; Requesting the Northwest Louisiana Finance Authority Enter into Said Payment in Lieu of Tax Agreements; and Providing for Other Matters with Respect Thereto

Mr. Mike Busada discussed the SR Sabine LLC Solar Project PILOT Agreement with the Northwest Louisiana Finance Authority. He noted that the agreement was substantially the same as the two agreements previously approved by the Sabine Parish Police Jury.

Resolution No. 9414

A RESOLUTION APPROVING PAYMENT IN LIEU OF TAX AGREEMENTS IN ACCORDANCE WITH A TERM SHEET; REQUESTING THE NORTHWEST LOUISIANA FINANCE AUTHORITY ENTER INTO SAID PAYMENT IN LIEU OF TAX AGREEMENTS; AND PROVIDING FOR OTHER MATTERS WITH RESPECT THERETO.

WHEREAS, the Parish of Sabine, State of Louisiana (the "*Parish*"), is a political subdivision of the state of Louisiana (the "*State*"); and

WHEREAS, the Sabine Parish Police Jury acts as the governing authority of the Parish (the "Sabine Parish Police Jury"); and

WHEREAS, SR Sabine, LLC, a corporation qualified to do business in the State (the "*Company*" or "*Lessee*"), desires to construct a solar photovoltaic facility in the Parish with a capital investment of approximately \$840 million (the "*Project*"); and

WHEREAS, in order to make the Project economically viable, the Company has requested economic development financing in the form of certain tax abatements; and

WHEREAS, the Sabine Parish Police Jury has found and determined that attracting the Project to Sabine Parish would provide substantial benefits including, but not limited to, increased ad valorem and sales and use tax revenue for the Parish and additional energy offerings to attract new business and industry, which when taken together result in benefits to the Parish equal to or greater than the benefits requested by the Company; and

WHEREAS, the Northwest Louisiana Finance Authority ("*NWLFA*") is a statutorily authorized local public trust permitted to acquire and hold property for one or more of its public purposes as set forth in R.S. 9:2341(B) and upon acquisition by NWLFA, such property is declared for purposes of R.S. 9:2347(M) to be public property used for essential and

governmental purposes and such property is thereby exempt from all taxes of the Parish, the State, or any political subdivision thereof or any other taxing body; and

WHEREAS, the Parish requests NWLFA take title to the Project and lease it back to the Company for a period of twenty (20) years pursuant to a term sheet (the "*Term Sheet*"), which is attached hereto as **Exhibit A** and incorporated herein; and

WHEREAS, the Parish desires the Lessee to pay annually to parish or municipal taxing authorities, and to any other taxing body in the Parish, through the entity responsible for collecting ad valorem taxes for each taxing body (collectively, the "*Tax Collector*"), a sum in lieu of ad valorem taxes in an amount not to exceed the amount of taxes that would otherwise be due if the Project were not owned by the NWLFA (a "*PILOT*"), in accordance with the Term Sheet, in order to compensate such authorities for services rendered by them to the Project, which sum the Tax Collector shall collect and enforce payment of in accordance with the statutory provisions of La. R.S. 39:1002 as statutory impositions, subject to the approval of the beneficiary of NWLFA; and

WHEREAS, the Term Sheet provides that the PILOT shall commence upon the conveyance of the Project to the NWLFA and shall terminate at 11:59 P.M. on the last day of the two hundred and fortieth (240) month after commencement (the "PILOT Termination Date"), and that full ad valorem taxes will be paid to the Tax Collector following the PILOT Termination Date; and

WHEREAS, the Sabine Parish Police Jury further requests that NWLFA effectuate through a contractual payment in-lieu-of tax (a "Contractual PILOT") an exemption from the state-imposed sales and use taxes on construction material and equipment purchased during initial construction of the Project, while facilitating the collection of funds equal to the amount of sale and use taxes that would otherwise be due to all local taxing bodies but for the Contractual PILOT and transferring said funds to each taxing body.

NOW, THEREFORE, BE IT RESOLVED by the Sabine Parish Police Jury that:

Section 1. The foregoing whereas clauses are hereby adopted as set forth in the preamble to this Resolution.

Section 2. This Parish does hereby request that the NWLFA enter into the PILOT agreements in accordance with the attached and approved Term Sheet.

Section 3. The President and Secretary-Treasurer are hereby authorized, empowered, and directed to take forthwith any and all such action as may be necessary to carry into effect the provisions of this Resolution.

Section 4. If any one or more of the provisions of this Resolution shall for any reason be held to be illegal or invalid, such illegality or invalidity shall not affect any other provision of this Resolution, but this Resolution shall be construed and enforced as if such illegal or invalid provisions had not been contained herein. Any constitutional or statutory provision enacted after

the date of this Resolution which validates or makes legal any provision of this Resolution which would not otherwise be valid or legal, shall be deemed to apply to this Resolution.

Section 5. This Resolution shall immediately take effect upon adoption.

Said Resolution having been read and considered by a quorum of the Police Jury, on motion to adopt by McCormic, seconded by Ebarb, a record vote was taken and the following result was had:

ECONOMIC DEVELOPMENT FINANCE TERM SHEET

Authority: Northwest Louisiana Finance Authority

Company: SR Sabine, LLC

Parish: Sabine Parish, Louisiana

Property: Certain immovable real property located on the Site (as outlined in **Exhibit A**).

Project: Transformation of the Site into a solar photovoltaic facility with a capital investment of at least \$840,957,000. The Project will have a nameplate capacity of 450 MWac utilizing thousands of PV modules that are transformed to 34.5kV for delivery via underground cables to a substation.

Lease Term: The Lease shall expire after twenty (20) years or upon the termination of the Incentive Period (defined below).

Property Tax Incentive: Exemption of Project from eighty percent (80%) of ad valorem taxes for a period of twenty (20) years (the "Incentive Period").

Payment in Lieu of Taxes: During the time in which the Authority owns the Project, the Company shall be responsible for making an annual payment in lieu of taxes (the "Annual PILOT"). The payments reflect a percentage of ad valorem taxes that would otherwise be paid by the Company if not for the abatement.

Base PILOT Payments: The Base PILOT payments are equal to 20% of the ad valorem taxes that would otherwise be due in a given tax year but for the PILOT Agreement.

Option to Purchase: The Company shall have the option to purchase the Project from the Authority for a purchase price of \$1,000 at any time upon payment in full of any amounts that are actually then due, owing and/or past due under the Lease.

Fees: The Company agrees to pay the following fees:

- (a) At the signing of this term sheet, the non-refundable application fee in the amount of \$3,000.
- (b) Upon execution of the Act of Conveyance of the Project, or a substantial portion thereof, the closing fee of the Authority in the amount of 1/10th of 1% of the capital cost of the property subject to the exemption under the PILOT,
- (c) Upon execution of the PILOT Lease Agreement and S&U PILOT Agreement (defined below), the legal fees of counsel to the Authority; and
- (d) On the 1st day of December in each calendar year, commencing the year immediately following the conveyance of the Project, or a substantial portion thereof, to the Authority, the Company shall pay to the Authority an annual administrative fee in the amount of 1/20th of 1% of the capital cost of the property subject to the exemption under the PILOT.

Sales & Use Tax PILOT: The Authority shall effectuate an exemption from the state-imposed sale and use taxes on construction material and equipment purchased during initial construction of the project, which shall commence upon the execution of the sales and use tax PILOT Agreement (the "S&U PILOT Agreement") and end upon the receipt of certificate of occupancy (the "Construction Period").

On a quarterly basis during the Construction Period, Company shall make an administrative payment to the Authority equal to 30% of the state-imposed sales and use taxes that would otherwise be due but for a S&U PILOT Agreement. Additionally, Company shall also make a payment to the Authority equal to 100% of the local, nonstate sales and use taxes that would otherwise be due but for a S&U PILOT Agreement, which funds will be provided to all local

taxing authorities in amounts corresponding to the amount of sales and use taxes that would have otherwise been collected by those authorities but for the S&U PILOT.

This term sheet (the "Term Sheet") provides a summary of certain financial terms offered to the Company by Sabine Parish. The terms herein are subject to additional terms and conditions as negotiated by the parties and contained in a PILOT Lease and a S&U PILOT Agreement, along with related documents (the "PILOT Documents"). This Term Sheet serves as a basis to move forward pursuant to the guidelines contained herein. By signing below, the parties agree to work in good faith to negotiate the PILOT Documents. Neither party is bound to execute the PILOT Documents. This Term Sheet is subject to approval of the Sabine Parish Police Jury and the Authority. This Term Sheet shall expire within ninety (90) days of execution, or upon the execution of the PILOT Lease, whichever occurs first.

18. <u>Stan Hazlip- 2024 Renewal of Health and Dental Insurance</u>

Mr. Stan Hazlip presented a renewal proposal for group health care and dental coverage from the Parish Government Risk Management Agency (PGRMA). There were no significant changes from the prior year's coverage. The following are significant features of the option presented to the Police Jury:

- \$750/\$2,250 deductible
- \$3,500 out-of-pocket maximum

- 100% coverage for insulin and diabetic supplies
- 80% co-insurance in network- 60% co-insurance out of network

The estimated annual premium is \$1,176,334.71, an increase of approximately 2.5% (\$29,845.95).

19. <u>Introduce an Ordinance Establishing a Fifteen Miles Per Hour Speed Limit on the North End of Patrick Road Located in Ward 7 (Road District 4)</u>

Secretary Treasurer Weatherford introduced the proposed ordinance by reading it aloud.

ORDINANCE No. 17 of 2023

AN ORDINANCE ESTABLISHING A FIFTEEN (15) MILES PER HOUR SPEED LIMIT ON THE NORTH END OF PATRICK ROAD LOCATED IN WARD 7 (ROAD DISTRICT 4)

WHEREAS, the Sabine Parish Police Jury is responsible for the safety of individuals traveling on parish roads, and

WHEREAS, the current posted speed limit for the north end of Patrick Road, located in Road District 4 (Ward 7), allows drivers to travel at speeds of up to forty-five (45) miles per hour without being issued a citation, and

WHEREAS, the Sabine Parish Police Jury has determined that this is a dangerous speed for travel on the north end of Patrick Road located in Road District 4 (Ward 7).

NOW THEREFORE BE IT ORDAINED, that the maximum speed limit for any vehicle travelling on the north end of Patrick Road, located in Road District 4 (Ward 7) shall be fifteen (15) miles per hour.

BE IT FURTHER ORDAINED, that this ordinance shall be in effect December 31, 2023, and it shall be published one time in the Official Journal of the Parish of Sabine, State of Louisiana, along with any other minutes of the meeting.

ORDINANCE No. 16 of 2023
