14a. Consider Parish Comprehensive Plan

Mr. Mike Mancil, with the Sabine Parish Economic Development Board informed the Jury that the Board has contacted Tipton Associates to perform a comprehensive plan for the Parish. He stated that the comprehensive plan would assist in obtaining grants to help promote economic development and would cost approximately \$140,000. He requested the Jury to utilize funds allocated for industrial development (approximately \$92,000) to offset the cost of the plan. Mayor Hable of the Town of Many stated that he had spoken with the mayors of all the other municipalities, and all were interested in having the project complete to promote economic development throughout the Parish. Secretary Treasurer Weatherford proposed entering into a Cooperative Endeavor Agreement with the Town of Many to engage Tipton Associates to perform a comprehensive plan for Sabine Parish.

WHEREAS, the Town of Many has agreed to enter into a Cooperative Endeavor Agreement with the Sabine Parish Police Jury to engage Tipton Associates to perform a comprehensive plan for the Parish NOW, THEREFORE BE IT RESOLVED, that the Sabine Parish Police Jury is hereby authorized to enter a cooperative endeavor agreement with the Town of Many, Louisiana to provide a comprehensive plan for Sabine Parish, and

BE IT FURTHER RESOLVED, that the police jury president is hereby authorized to execute any documents necessary to complete the agreement.

RESOLUTION

A resolution providing for canvassing the returns and declaring the results of the special election held in Road District No. 4, Ward 7 of Sabine Parish, Louisiana, on Tuesday, November 5, 2024, to authorize the levy of a special tax therein.

BE IT RESOLVED by the Police Jury of the Parish of Sabine, State of Louisiana (the "Governing Authority"), acting as the governing authority of Road District No. 4, Ward 7 of Sabine Parish, Louisiana (the "District"), that:

SECTION 1. <u>Canvass</u>. This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in the District, on TUESDAY, NOVEMBER 5, 2024, to authorize the levy of a special tax therein, and said Governing Authority does further proceed to examine and canvass the returns and declare the result of the special election.

SECTION 2. <u>Election Results.</u> According to the official certified tabulation of votes cast at said Election, there was a total of **204** votes cast **IN FAVOR OF** Proposition and a total of **233** votes cast **AGAINST** Proposition, resulting in a majority of **29** votes cast **AGAINST** Proposition. The Proposition was therefore duly **DEFEATED** by a majority of the votes cast by the qualified electors voting at the Election.

SECTION 3. <u>Promulgation of Election Result.</u> The results of said election shall be promulgated by publication in the manner provided by law, after receipt from the Secretary of State's office of the actual costs of the election, as required by §18:1292 of the Louisiana Revised Statutes of 1950, as amended.

SECTION 4. <u>Declaration</u>. The foregoing results of the Election are hereby declared by this Governing Authority and shall be published as required by law.

SECTION 5. <u>Procès Verbal</u>. A *Procès Verbal* of the canvass of the returns of said election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge,

Louisiana, who shall record the same in her office; and another copy thereof shall be retained in the archives of this Governing Authority.

BE IT KNOWN AND REMEMBERED that on Wednesday, December 18, 2024, at 9:00 a.m., at its regular meeting place, the Police Jury Room of the Courthouse, 400 Capitol Street, Many, Louisiana, the Police Jury of the Parish of Sabine, State of Louisiana (the "Governing Authority"), acting as the governing authority of Road District No. 4, Ward 7 of Sabine Parish, Louisiana (the "District"), and being the authority ordering the special election held therein on Tuesday, November 5, 2024, with a quorum being present, did examine the official certified tabulations of votes cast at the said election, and did examine and canvass the returns of said election, there having been submitted at said election the following proposition to wit:

ROAD DISTRICT NO. 4, WARD 7 PROPOSITION (TAX)

Shall Road District No. 4, Ward 7 of Sabine Parish, Louisiana (the "District"), levy a 13.88 mills tax on all the property subject to taxation within the District (an estimated \$395,500 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of 10 years, beginning with the year 2025 and ending with the year 2034, for the purpose of constructing, improving, maintaining and/or repairing public roads and bridges in the District, including ditching and drainage therefor and purchasing equipment therefor?

There was found by said count and canvass that there was a total of **204** votes cast **IN FAVOR OF** Proposition and a total of **233** votes cast **AGAINST** Proposition, as hereinabove set forth, and it was further found and determined that there was a majority of **29** votes cast **AGAINST** Proposition as hereinabove set forth.

Therefore, the Governing Authority did declare and proclaim and does hereby declare and proclaim in open and public session that the Proposition as hereinabove set forth was duly **DEFEATED** by a majority of the votes cast by the qualified electors voting at the said special election.

23. Federal Off System Bridge Replacement Program – Annual Certification of Compliance

Resolution No. 9693

ANNUAL CERTIFICATION OF COMPLIANCE WITH STATE OF LOUISIANA OFF SYSTEM BRIDGE REPLACEMENT PROGRAM

WHEREAS, the Code of Federal Regulations, as enacted by the United States Congress, mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity, and posted in accordance with the National Bridge Inspection Standards, and that an inventory of these bridges be maintained by each state; and

WHEREAS, the responsibility to inspect, rate, and load post those bridges under the authority of Sabine Parish, in accordance with those Standards, is delegated by the Louisiana Department of Transportation and Development to Sabine Parish.

NOW, THEREFORE, BE IT RESOLVED by the governing authority of Sabine Parish, Louisiana convened in Regular Session on the 18th day of December, that it does hereby certify to the Louisiana Department of Transportation and Development (DOTD) that for the period of January 1, 2025 through December 31, 2025:

- 1. The Parish will perform all interim inspections on all parish-owned or maintained bridges in accordance with the National Bridge Inspection Standards and Specifications for the National Bridge Inventory;
- 2. All bridges owned or maintained by the Parish will be structurally analyzed and rated by the Parish as to the safe load capacity in accordance with the American Association of State Highway and Transportation Officials (AASHTO) Manual for Bridge Evaluation. The load posting information that has been determined by DOTD for all bridges where the maximum legal load under Louisiana State Law exceeds the load permitted under the operating rating as determined above will be critically reviewed by the Parish. Load posting information will be updated by the Parish to reflect all structural changes, any obsolete structural ratings, or any missing structural ratings;

- 3. All Parish-owned or maintained bridges which require load posting or closing will be load posted or closed in accordance with the table in the DOTD Load Rating Directives. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting; and
- 4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplied to the Parish by the DOTD are noted.
- 5. All bridges owned and maintained by the Parish are accessible to DOTD for all routine bridge inspections. Parish will clear vegetation as required upon DOTD request.

These stipulations are prerequisites to participation by the Parish in the Off-System Bridge Replacement Program.
