1. Call to Order

President Ricky L. Sepulvado called the meeting to order.

2. Roll Call

The roll was called by the Secretary Treasurer. The following jurors were present: Mike McCormic, William E. Ruffin, Stephen Steinke, “Jeff” Davidson, Eric Garcie, Ricky ”K-Wall” Sepulvado, Kenneth M. Ebarb, and “Randy” Byrd.

The following juror was absent or arrived late: “Bo” Stewart.

3. Prayer

Prayer was led by Mr. William E. Ruffin.

4. Pledge of Allegiance

The Pledge of Allegiance was led by Mr. “Randy” Byrd.

Mr. “Bo” Stewart joined the meeting.

7. Public Comments

Police Jury President, Ricky L. Sepulvado, allowed a period of public comment on any item on the agenda.

Mrs. Rebekah Stiegemeyer expressed her opposition to the Police Jury's policy for public comments which allows five minutes for each individual to comment on any item(s) on the agenda.

Secretary Treasurer William E. Weatherford commented that he had polled the other parishes in Louisiana to determine their public comments policies. He noted that of the parishes responding to his inquiry, forty-seven (47) parishes reported having a policy that limits the length of a public comment and thirty-four (34) parishes reported the use of a timer. Parishes limited the duration of public comments for periods from two (2) minutes to ten (10) minutes with the mode for the allowed time being three (3) minutes.

Mr. Pat Scarborough expressed his opposition to the Police Jury's policy for public comments.

8. Representative Rodney Schamerhorn

Representative Rodney Schamerhorn was not in attendance.

9. Mr. Jesse Pollard – Project Development at Galehead Development

Mr. Jesse Pollard with Galehead Development discussed the proposed Payment in Lieu of Taxes (PILOT) program which is designed to advance the solar farm project. Mr. Pollard reviewed the Term Sheet for the Hollis Creek Project and explained how the payments to be received by the Parish will be distributed.

President Sepulvado requested that Galehead Development explore ways to retain the local fox pen in the project area including the possibility of relocation. Mr. Pollard indicated a willingness on the part of the company to work towards this goal.

10. Mr. Mike Busada – Program Counsel NLFA

Mr. Mike Busada, Program Counsel for the Northwest Louisiana Finance Authority discussed the proposed Resolution Approving an Annual Payment of Tax in Accordance with a Term Sheet Issued by the Northwest Louisiana Finance Authority.

He stressed that the Northwest Louisiana Finance Authority is representing Sabine Parish and working to protect the Parish's interests. He noted that the money received under the Payment in Lieu of Taxes (PILOT) program due to the Parish under the Term Sheet will be collected by the sheriff and distributed to the various taxing authorities in the same manner as regularly collected ad valorem tax receipts.

Mr. Ruffin requested that the resolution be reviewed and approved by District Attorney Don Burkett prior to adoption by the Police Jury. President Sepulvado stated that a special called meeting will be held to consider adoption of the resolution after receiving approval from Mr. Burkett.

11. Planning Commission

No representative from the Sabine Parish Planning Commission was present at the meeting.

12. Consider Approving a Cooperative Endeavor Agreement for Revitalization of the Many Junior High School

Consideration of approval of a cooperative endeavor agreement to support the revitalization of the Many Junior High School was tabled during the January 18, 2023 meeting of the Police Jury. Mr. William Ruffin expressed his support for the agreement noting that it would provide many benefits to the parish youths. Mr. "Bo" Stewart expressed his opposition to the agreement noting that his constituents wanted all possible funds to be expended for road repairs.

17. Adopt New Disposal Fees for the Landfill to be Effective March 1, 2023

Mr. Pete Chreene, Jr. has informed the Police Jury that because of significant increases in fuel and other operating costs the disposal fees being charged at the solid waste landfill need to be increased by three percent (3%). He has proposed a schedule of new fees to be effective March 1, 2023. The Solid Waste Committee has reviewed the proposed increases and recommended adoption of the new fee rates.

Municipal Solid Waste:

\$50.50 per ton plus 15% environmental fee

Special Waste:

Special waste includes any waste that requires testing and handling. 24 hours prior notice of delivery is required. Special waste is accepted from 7:00 am until 4:00 pm., Monday through Friday.

Industrial solids and sludges require a waste characterization form, a DEQ waste number and a test from an approved laboratory. Each load will require a waste manifest.

Industrial Solids:

\$34.00 per ton

Exploration and Production:

\$15.45 per ton

Industrial Sludges and ALL Liquids:

\$.85 per gallon

Waste Drum Handling Fee included disposal:

\$134.00 per drum solid

\$145.00 per drum liquid
\$71.00 per tote plus .85 per gallon

Asbestos Waste:

Asbestos waste is only accepted by appointment. Asbestos must be transported in noncompatible vehicles and must have a waste manifest and a test from an approved laboratory. All friable asbestos requires a completed DEQ Asbestos Disposal Verification Form. Operator and any passengers must wear **protective clothing while on site.**

Minimum charge for friable and non-friable \$43.50 per cubic yard

Special Handling Waste:

Includes items that require immediate burial, materials with high dusting potential, bulky waste, pharmaceutical drugs, outdated products, tree stumps and logs, and other items that require special handling procedures.

Special Handling Waste \$28.00 per ton

Large Stumps or Logs:

Stumps and logs with a diameter of thirty (30) inches or larger and logs over six feet in length shall be charged a fee for each stump or six-foot section, plus the normal waste fee per ton.

Large Stumps or Logs \$33.00

Animals:

Require direct burial.

Small Animals \$49.50 each
Large Animals \$170.00 each

Other Miscellaneous:

Construction and Demolition Waste \$ 25.75 per ton

25. Committee Reports

Courthouse Committee:

Mr. “Bo” Stewart, chairman of the Courthouse Committee, reported on enhanced security discussed with Judge Gentry. Effective February 22, 2023 the following procedures will be employed:

- All visitors shall be required to enter and exit the courthouse through the glass sliding doors facing South Capitol Street.
- Sabine Parish Sheriff deputies will be stationed at the Capitol Street Entrance to operate a security checkpoint.
- Every courthouse visitor will be subject to a security screening for weapons and/or dangerous instrumentalities.
- Visitors are prohibited to carry any bag, purse, package, briefcase, or other closed container into the Courthouse.
- All courthouse doors other than the Capitol Street Entrance shall be closed to the public.

Road and Shop Committee:

Road Superintendent Bobby Hughes reported that the Parish is now undergoing the two-year inspection of all parish bridges by the Louisiana Department of Transportation and Development. He noted that two bridges have been identified for closure. One bridge will be replaced by tank car shells but the Baron Road bridge is expected to remain closed for an extended period of time. It was the consensus of the Jury to engage an engineering firm to review the Baron Road bridge and provide options for its replacement.

26. Financial Report

Secretary-Treasurer William E. Weatherford presented a financial report to the Jury. He provided the ending cash balances of all funds as of December 31, 2022 and bank balances as of January 31, 2023. Mr. Weatherford also briefly described the restrictions and dedications of the various accounts.
