1. Call to Order

President Ricky L. Sepulvado called the meeting to order.

2. Roll Call

The roll was called by the Secretary Treasurer. The following jurors were present: “Bo” Stewart, Barry Stevens, Ronny Bison, Bruce Taylor, Ricky “K-Wall” Sepulvado, Kenny John Remedies, and Randy Byrd.

3. Prayer

Prayer was led by Secretary Treasurer Weatherford.

4. Pledge of Allegiance

The Pledge of Allegiance was led by Mr. Kenny John Remedies.

Mr. Eric Garcie joined the meeting.

5. Amend the Agenda

There was no amendment to the agenda.

6. Adopt the Agenda

7. Public Comments

Police Jury President, Ricky L. Sepulvado, allowed a period of public comment on any item on the agenda.

Mr. Loyd Mason, an employee of the Sabine Parish Police Jury, commented on Agenda Item 25- Consider Changing the Payroll from Semi-Monthly to Bi-Weekly. He suggested the payroll frequency be changed from semi-monthly to bi-weekly for the sake of simplicity.

Mr. Harold Procell, an employee of the Sabine Parish Police Jury, commented on Agenda Item 25- Consider Changing the Payroll from Semi-Monthly to Bi-Weekly. He stated that he was unaware of how the payroll was calculated and asked the Police Jury to consider changing the payroll frequency to bi-weekly.

8. Senator Alan Seabaugh

Mrs. Laurie Gentry, with Senator Alan Seabaugh's office, thanked the Police Jury for their services to the Parish and welcomed all jurors to visit Senator Seabaugh's office should they ever need assistance.

9. Representative Rodney Schamerhorn

No representative from Representative Rodney Schamerhorn's office was present at the meeting.

10. Representative Larry Bagley

Representative Larry Bagley informed the jurors of the appropriated funds that Sabine Parish entities would be receiving with House Bill No. 2.

11. Planning Commission

No representative from the Sabine Parish Planning Commission was present at the meeting.

12. Mr. Don Burkett, District Attorney- Discuss Special Events Held in the Parish

Mr. Don Burkett, District Attorney, requested the Police Jury to adopt an ordinance requiring the issuance of special event permits for organizations that want to house events with large crowds in the Parish. He advised the Police Jury to review the current adopted ordinance of the Desoto Parish Police Jury and suggested Sabine Parish to adopt a similar one. He stated that he would be willing to work with the Police Jury administrative staff, along with the Sheriff's office, to get the ordinance drafted before it is brought to the Jury for adoption. The consensus of the Jury was to adopt an ordinance comparable to the one adopted by the Desoto Parish Police Jury. The Secretary Treasurer proposed introducing the ordinance by name during this meeting and adopting it during the next regularly scheduled meeting.

The Secretary Treasurer then introduced the ordinance by name: An Ordinance Establishing Policy and Procedures for Monitoring and Controlling Special Events Held Within the Boundaries of Sabine Parish, Louisiana

13. Mr. Brian C. Mcrae- Chief Defender, 11th, 39th, and 42nd Judicial Districts- Request for Funding from the Opioid Abatement Fund

Mr. Brian C. McRae, Chief Defender, introduced himself to the Police Jury and stated that his office will be required to participate in the new drug court system that will be run in Sabine Parish. He informed the Jury that his office will be responsible for providing representation and data collection. He mentioned that currently there are no state or local funds for his office to accommodate this added expense. He requested \$15,000 from the Opioid Abatement money to be used for drug court expenditures during the period of July 1, 2024, through December 31, 2024. He stated that the \$15,000 could be distributed evenly over the six-month period.

Resolution No. 9592

On motion by Stevens and seconded by Taylor:

WHEREAS, the Sabine Parish Police Jury is the recipient of funds through the Opioid Abatement Settlement Fund; and

WHEREAS, these monies are restricted to use for substance abuse, and

WHEREAS, the Chief Defender of the 11th, 39th, and 42nd Judicial Districts has requested \$15,000 to be distributed to him for drug court expenditures.

NOW, THEREFORE, BE IT RESOLVED, that the Sabine Parish Police Jury pay the Chief Defender of the 11th, 39th, and 42nd Judicial Districts the sum of \$15,000 from the Opioid Abatement Fund; and

BE IT FURTHER RESOLVED, the sum of \$15,000 be disbursed evenly over the six-month period beginning July 1, 2024, and ending December 31, 2024 (\$2,500 per month).

BE IT FURTHER RESOLVED, that the Secretary Treasurer disburse these funds as soon as possible.

14. Mrs. Gracie Skinner-Rural Transit Program Manager, Rural Public Transit Pilot Program (RPTP)

Mrs. Gracie Skinner addressed the Police Jury and shared the progress of the pilot program from the past two years and mentioned the possibility of expansion into Sabine Parish. Currently, the program provides curb-to-curb transportation service throughout the combined Grant and Natchitoches Parish area as part of a pilot operated by the Rapides Area Planning Commission. The transportation service provides rides locally and to nearby destinations but requires a ride reservation be made in advance. Mrs. Skinner also informed the Jury that all vehicles are ADA accessible. To assist with expansion of services into Sabine Parish, Mrs. Skinner requested that \$26,000 of matching funds be collected from the Police Jury. She left the Secretary Treasurer and Assistant Secretary Treasurer contact information for her office and asked the jurors to contact it should anyone have any questions.

15. Mr. Stanley Cook, Deputy Coroner - Report on the Coroner's Office Activities During the Period of April Through June 2024

Mr. Stanley Cook, Deputy Coroner, reported on the activities and accomplishments of the Sabine Parish Coroner's Office during the second quarter of 2024.

Mr. Cook reported that the Coroner's Office worked 60 deaths, committed 61 individuals, and worked 17 pending investigations.

16. Mrs. Cheryl Wooley- Many Chief of Police-Discuss Security Cameras for the Fair Grounds and Dixie Youth Field

Mrs. Cheryl Wooley, Many Chief of Police, informed the Police Jury that the Many Police Department had recently obtained some security cameras through the Project N.O.L.A Crime Camera Program. The cameras will be placed in needed places throughout the Town of Many and live video will be transmitted to the Project NOLA National Real-Time Crime Center (RTCC) located at the University of New Orleans, in addition to local law enforcement. She stated that the cameras were free, and the only cost associated with each camera was an annual cloud storage fee. She encouraged the Jury to consider obtaining cameras for the Rodeo Arena and Dixie Youth field.

20. Consider Renewal of Inmate Medical Care Contract

On August 19, 2020, through Resolution No. 8621, the Police Jury entered an agreement with Toledo Health, LLC for the provision of non-emergent medical and chronic care needs of inmates housed at the Sabine Parish Detention Center and the Sabine Parish Women's Facility with a monthly cost of \$6,000. The Police Jury renewed this agreement on July 15, 2022, with a termination date of July 31, 2024. Toledo Health, LLC has provided a proposal to renew the agreement with a monthly cost of \$8,000 to the Police Jury, and a termination date of July 31, 2028.

AN ORDINANCE TO AUTHORIZE AN ACT OF SALE BY THE PARISH OF SABINE TO SELL CERTAIN ADJUDICATED PROPERTIES (PARCELS 9087002000 & 9011013725) AND, FURTHER PROVIDING WITH RESPECT THERETO.

WHEREAS, an offer has been made to the Parish by an individual who qualifies for the Parish Lot Next Door Program for *PARCEL# 9087002000 and Parcel 9011013725* further defined by Ordinance 1 of 2017 and such offer is for the sum that equates to the minimum bid in compliance with such Ordinance and with state laws:

WHEREAS, the redemption period provided by Art. 7, §25 of the Louisiana Constitution has elapsed, established by Parish Ordinance No: 1 of 2017 and the owner of record has failed to redeem the adjudicated property; and

WHEREAS, LA R.S. 47: 2202 *et seq.* provides that the Parish may sell adjudicated property in accordance with law after the expiration of the period for redemption; and

WHEREAS, the Parish of Sabine has declared the property described below surplus and not needed for a public purpose and to dispose of said property in accordance with LA R.S. 47:2202, *et seq.*; and

WHEREAS, in accordance with L.A. R.S. 47:2202 the Parish of Sabine has set a minimum bid for public sale for each property and

WHEREAS, the property described herein above was offered at public auction on listed dates.

NOW BE IT ORDAINED by the Sabine Parish Police Jury, that any Act of Sale of the below described property shall contain the following conditions and requirements:

- 1) The properties shall be sold in accordance with LS-R.S. 47:2201 *et. seq.*, without any warranty, from either the Parish or Management Company, whatsoever, even as to the return of the purchase price.
- 2) The sale shall be on a form approved by the Parish Attorney and that the sales price is paid by certified funds at or near the time of the sale.

 - b. E&P Consulting Services, LLC has provided notice to those persons identified in accordance with LS-R.S. 47:2201 *et. seq.* Proof of said notice will be filed in the records of Sabine Parish immediately after the Act of Sale.
 - c. At the time of closing, the E&P Consulting Services, LLC will certify in writing to Parish Attorney and Clerk of Court that the number of days mandated by LS-R.S. 47:2201 *et. seq.* has elapsed since the above required notice was made or attempted and that the property has not been redeemed by the payment of the taxes owed.

BE IT FURTHER ORDAINED, by the Sabine Parish Policy Jury, that the Police Jury President is hereby authorized to execute a Cash Sale of the above described adjudicated properties to the highest acceptable bidder as named. The Cash Sale shall contain all of the above conditions and requirements and shall be executed within the timelines specified. 22. Consider Approval of a Cooperative Endeavor Agreement with the Town of Zwolle to Overlay Laroux Street

The Town of Zwolle, Louisiana desires to enter a cooperative endeavor agreement with the Sabine Parish Police Jury to overlay Laroux Steet.

Road Superintendent Bobby Hughes informed the Jury that Kinder Morgan, a gas pipeline company, had recently been working in Ward 3 and damaged several roads during their operations. Kinder Morgan has since reimbursed the Parish the cost of repairing the damaged roads.

25. Consider Amending the Parish Transportation Act Priority List

The Road and Shop Committee met on July 15, 2024, and recommended amending the current 3-year Parish Transportation Act Priority List to separate work to be performed on Bayshore Drive (Ward 3, Road District 9) into two phases and to move Phase I of the work higher on the list.

WHEREAS, Bayshore Drive is currently road number one on the 2025 Parish Transportation Act Priority List and is scheduled to be reclaimed, rocked and asphalted during 2025, and

WHEREAS, The Road Superintendent has requested separating the work into two phases to reclaim and rock Bayshore Drive in 2024 and overlay with asphalt in 2025, and

WHEREAS, The Road and Shop Committee has reviewed the request and recommends amending the 2024 Parish Transportation Act Priority List to include milling and rocking Bayshore Drive and amending the 2025 Parish Transportation Act Priority list to reflect only the asphaltting of Bayshore Drive.

NOW THEREFORE BE IT RESOLVED, that the current 3-year Parish Transportation Act Priority List be amended to reclassify the reclamation and asphaltting of Bayshore Drive into phases, with milling and rocking occurring in Phase I to be completed in 2024, and asphalt overlaying occurring in Phase II to be completed in 2025.

BE IT FURTHER RESOLVED, that the bi-weekly payroll frequency for all Road Department employees requesting bi-weekly payroll become effective August 1, 2024, and

BE IT FURTHER RESOLVED, that all new Road Department employees hired will be paid on a bi-weekly payroll schedule.
